WE CONTRIBUTED \$54,797 IN DIRECT SUPPORT TO TRAIN LOCAL HEALTH PROFESSIONALS AND TO SUBSIDIZE DRUG COSTS IN GHANA, THE PHILIPPINES, CAMEROON, BANGLADESH, AND MALAWI. 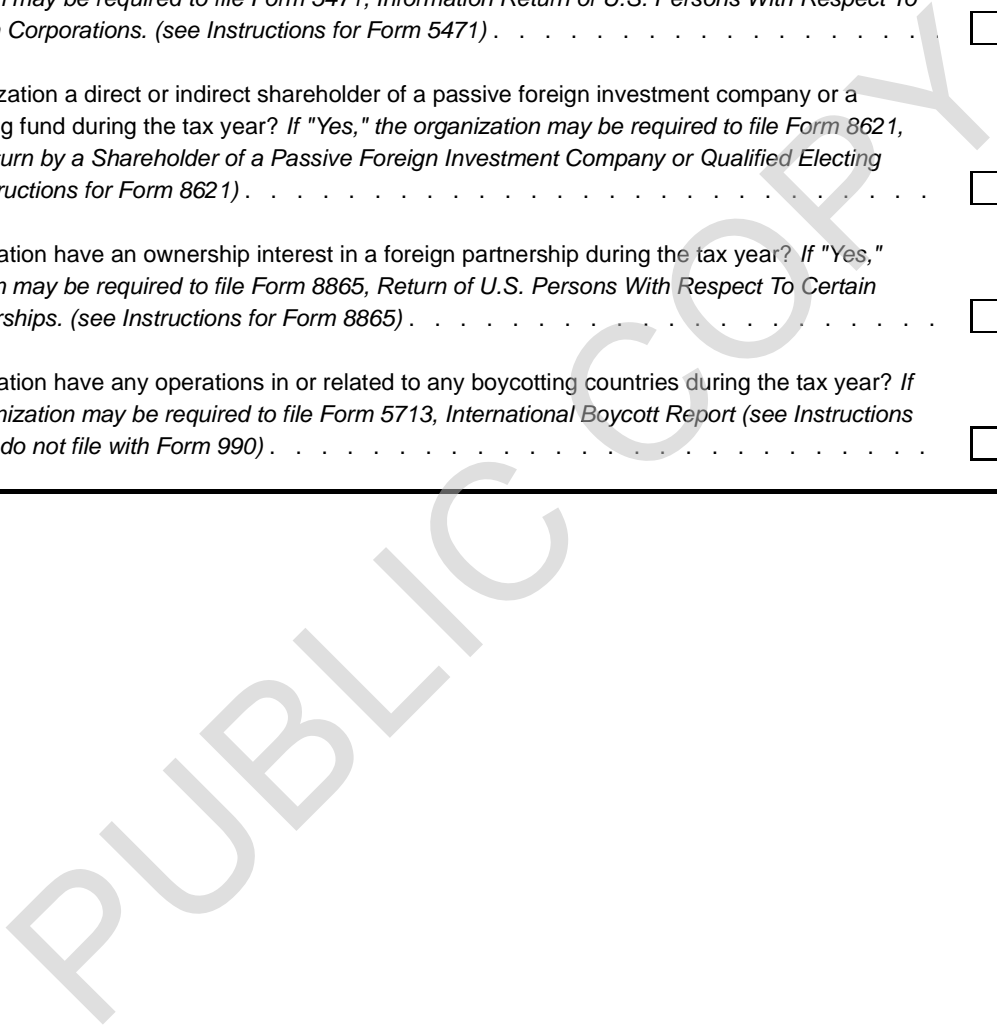

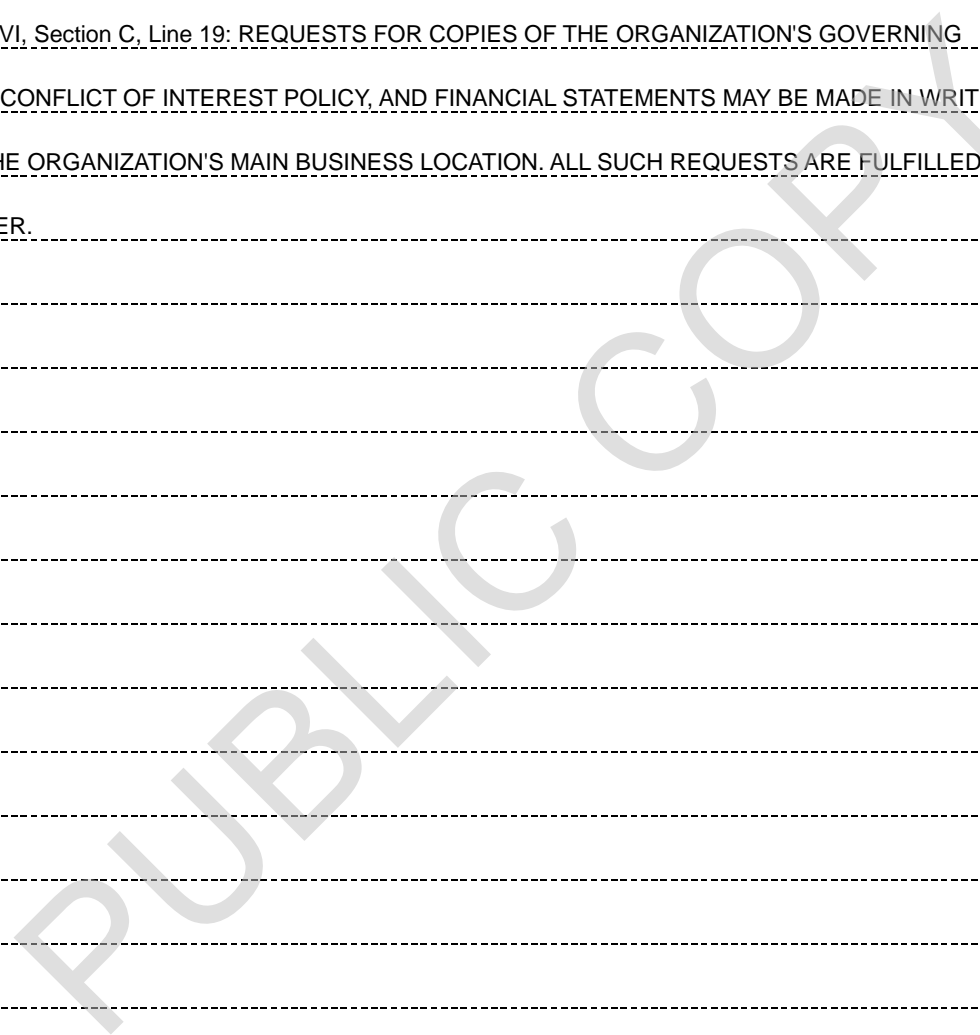
